OUR PROJECT

The Grassroots Europe for Local Wellbeing project gives European citizens active in the field of education and social inclusion the opportunity to interact among themselves, with policymakers and civil society organizations at the local, national and EU level.

At the local level it pursues a community-based, participatory approach and seeks to involve a diverse array of grassroots education organizations that work towards promoting soft factors for local development (culture, creativity, and innovation of citizens) and fostering local wellbeing through formal and informal education.

By convening citizens of diverse social and professional backgrounds, paying particular attention to the perspectives of disenfranchised groups, the project aims to enable local voices not typically heard to become a part of the Europe 2020 policy discussions around education integration issues, ensuring valuable interaction between EU decision-makers and those directly affected by EU policies.

This project is developed and implemented through the cooperation of 5 civil society education organizations from Austria, the Czech Republic, Hungary, Latvia and Romania. By benchmarking of successful community based grassroots activities that foster local wellbeing, and collecting policy recommendations for the local, regional, national and European Europe 2020 process, we believe that expertise and good practice can be shared across Europe.

THE EXPECTED IMPACT OF THE INITIATIVE

Representatives of more than 100 European grassroots education organizations will have the opportunity to contribute directly to debates, policy discussions, and the development of project models to foster local wellbeing through building a multicultural and inclusive society.

Partners will create a sustainable model of cooperation, able to further the policy agenda of linking grassroots education voices with policy discussions. Partners will develop the methodology for the project, organize and facilitate local roundtables, contribute to the final grassroots policy recommendations on local wellbeing generation, and begin building the institutional infrastructure for sustaining structured grassroots policy communication work.

Local, national and international policymakers will participate at various levels of the project throughout the year, i.e. taking part in local community roundtables, attending the project evaluation meeting, and discussing the recommendations of the grassroots organizations generated by the project.

By undertaking this project, partners will further develop their own capacity in working in the field of grassroots activism for local wellbeing, civic engagement, and active citizenship, advancing their theoretical and applied research in these fields, deepening their working partnerships with key NGOs operating throughout the EU.
